- I, Manoj Kumar Purbey, Practicing Company Secretary, appointed as Scrutinizer of Rotographics (India) Limited("the Company") for the purpose of scrutinizing the e voting and poll in a fair and transparent manner and ascertaining the requisite majority on e-voting and poll carried out as per the provision of section 108,109 of the companies act 2013 read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014 on the Resolutions contained in the Notice of the 41<sup>st</sup> Annual General Meeting of the members of the company held on Monday 26<sup>th</sup> day of September 2016 at 10:30 A.M. at 26 Sundervan, Vasant Kunj New Delhi -110070 submit my report as under:
  - 1. The company has availed e-voting facility from National Securities Depositary Limited ("e-voting facilitator") for enabling the shareholders to cast their votes electronically. E-Voting and Physical Ballot at the Annual General Meeting venue was conducted under my supervision. At the time of Physical Ballot, adequate care is taken such that no member who has cast his vote by remote e-voting prior to the meeting is allowed to cast his vote again at the Annual General Meeting venue.
  - 2. The e-voting period remained open from 9.00 A.M. on 23rd September 2016 till 5.00 P.M. on 25th September, 2016.





- 3. The Shareholders holding shares as on the "cut-off" date i.e. 23rd day of September, 2016 were entitled to vote on the proposed resolutions (Item No. 1 to 8) as set out in the Notice of 41st Annual General Meeting of the Company.
- 4. The locked ballot box was subsequently opened scrutinized. The poll papers were reconciled with Skyline Financial Services Pvt. Ltd. (Registrar and Transfer Agents) of the Company and the authorisations/proxies lodged with the Company
- 5. The remote votes were unblocked and thereafter the details, containing inter-alia the list of equity shareholders who voted "For" and "Against" were downloaded from the e-voting website of National Securities Depositary Limited and the same along with the information on Physical Balloting of votes during the Annual General Meeting are handed over to the Company Secretary of the Company.
- 6. No Poll Paper was incomplete and found defective
- 7. The poll papers and all other relevant records were sealed and handed over to the Company Secretary for safe keeping.

Based on the data downloaded from the official e-voting website of the e-Voting facilitator and the Physical Ballot conducted at the Annual General Meeting venue, the combined result (of e-voting & Physical Ballot) is given in the Annexure.
